## ► Year 2012

**Represented by Dr. Agung Laksono, from Coordinating Ministry of Human Development, Indonesia's commitments on family planning were declared on London Summit on Family Planning on July 11, 2012**

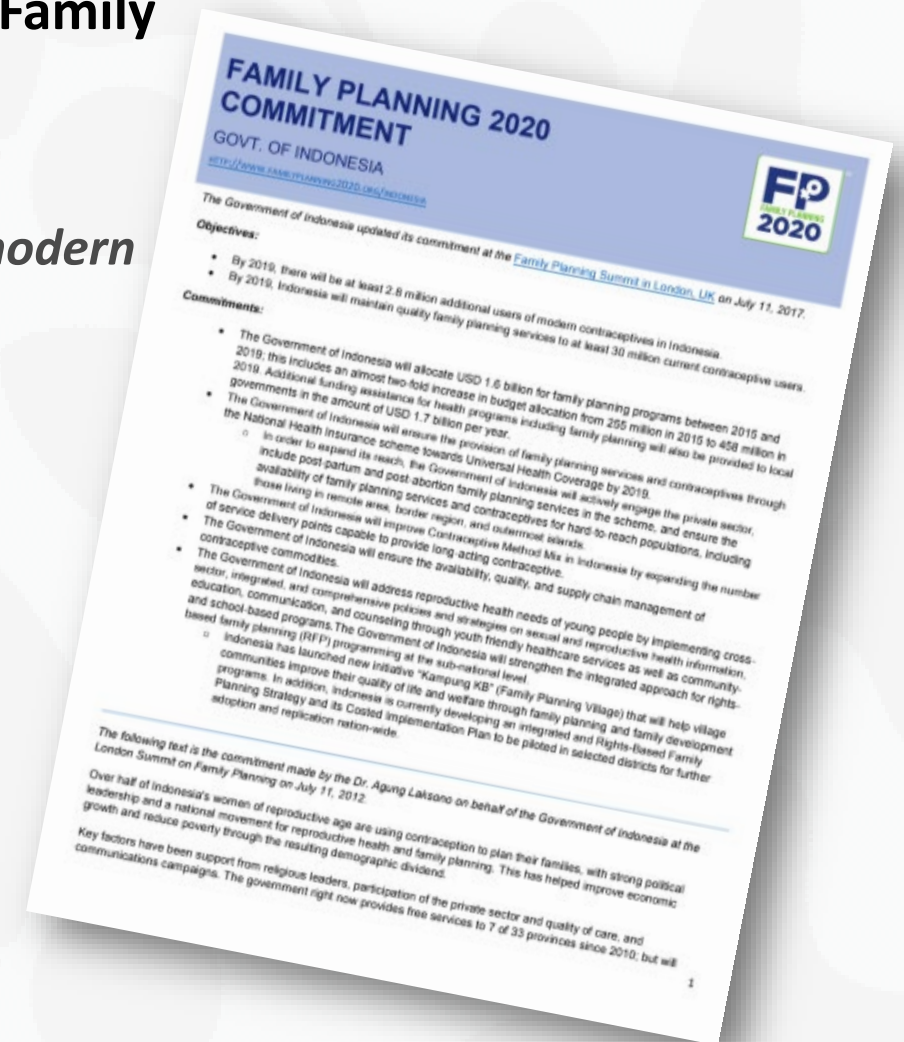


## ► Year 2017

Then in 2017, Indonesia revised the commitments on London Family Planning Summit, July 11 2017, with two focuses on :

**By 2019, there will be at least 2.8 million additional users of modern contraceptives in Indonesia.**

**By 2019, Indonesia will maintain quality family planning services to at least 30 million current contraceptive users.**

# **PROGRESS UPDATE INDONESIA'S FP2020 COMMITMENTS**

**JULY 2017 – SEPTEMBER 2019**

- *By 2019, there will be at least 2.8 million additional users of modern contraceptives in Indonesia*
- *By 2019, Indonesia will maintain quality family planning services to at least 30 million current contraceptive users*



## Progress on Data Summit

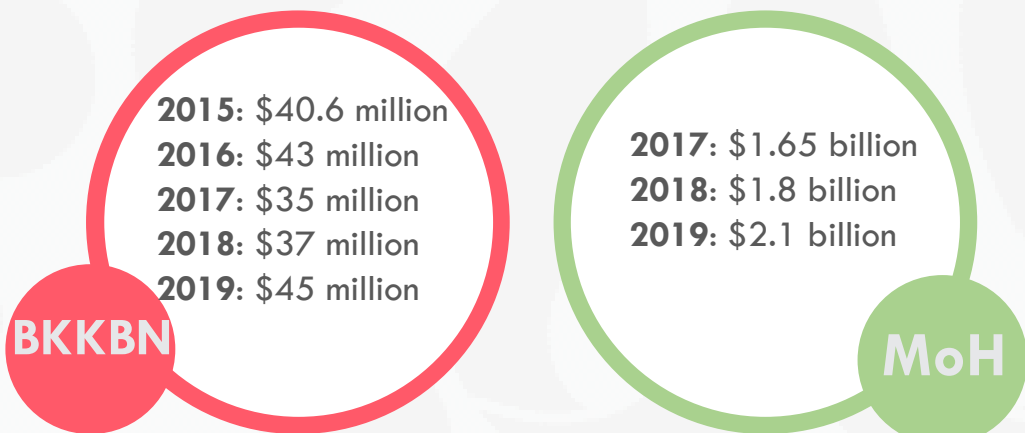
Data Summit was held on February 7th, 2018 and aim for synchronization of FP program data



*“The Government of Indonesia will allocate USD 1.6 billion for family planning programs between 2015 and 2019; this includes an almost two-fold increase in budget allocation from 255 million in 2015 to 458 million in 2019. Additional funding assistance for health programs including family planning will also be provided to local governments in the amount of USD 1.7 billion per year.”*

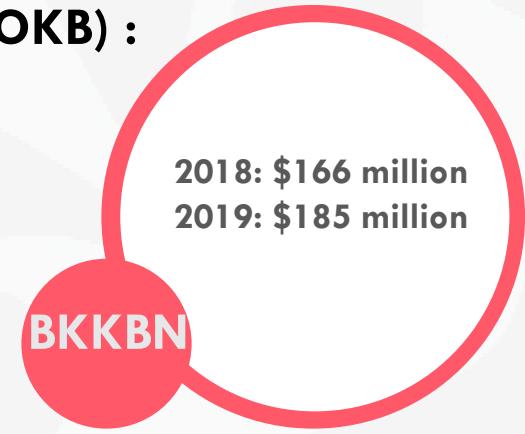


**Special Allocation Funds (DAK) to Local Governments :**

*“The Government of Indonesia will ensure the provision of family planning services and contraceptives through the National Health Insurance scheme towards Universal Health Coverage by 2019. In order to expand its reach, the Government of Indonesia will actively engage the private sector, include post-partum and post-abortion family planning services in the scheme, and ensure the availability of family planning services and contraceptives for hard-to-reach populations, including those living in remote area, border region, and outermost islands.”*

### Revised FP policy for BPJS

The latest policy was Presidential Decree No 82 year 2018; currently The MoH is in the process of develop a guidelines for FP services implementation in the era of UHC



### Private providers signed on BPJS

FKTP : 21,874 providing FP and signed on BPJS  
FKRTL : 2,389 providing FP and signed on BPJS



### Policy for post-partum/post abortion

A revision for MoH’s Decree (Permenkes) No 97 year 2014 is currently developed. BKKBN has also released Decree No 24/2017 for post-partum/post-abortion service in primary healthcare



### FP services for hardest-to-reach

BKKBN has released a Decree No 10 year 2018 which regulates the implementation of FP services for population with limited health facilities



### FP services for crisis & emergency

BKKBN is currently preparing contraceptive service guidelines in crisis / disaster areas which include pre-service, implementation and post-service



### Healthy Indonesia Program

FP indicators had been incorporated to the program as one of the 12 “Keluarga Sehat” indicators. FP participation indicator reached 50.62% of the total families received visitation and initial intervention

### Free-choice on SDPs

Range of contraceptives choice is based on healthcare level (FKTP and FKRTL). Most of the SDPs are “*sederhana*” level (93.57%) which provide pills, injection, condoms.

### Capacity Building by Govt/Public

Focusing 2019 in doctors-midwives certification (through MONIKA) in which the process has been accelerated with the issuance of advocacy letter by BKKBN to JNPK

### Total Market Assessment

The Total Market Assessment has been conducted to determine the proportion of contraceptive use between private and public sectors

### Capacity Building by Private Sectors

Private sectors have supported the Government of Indonesia in capacity building for health providers. Identified partners to date: DKT Indonesia, IPAS, JHPIEGO

### **BKKBN's Decree**

A Decree for National SCM to revise the previous Decree No 286/2011 is currently on final draft



### **Online Management System**

Developed from MIM Tools and has been piloted at 4 provinces



### **Technical Guidelines**

Currently being developed to support the National SCM Decree revision, the guidelines aim to improve the quality of supply chain process

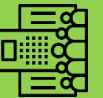

*“The Government of Indonesia will address reproductive health needs of young people by implementing cross-sector, integrated, and comprehensive policies and strategies on sexual and reproductive health information, education, communication, and counseling through youth friendly healthcare services as well as community-and school-based programs. The Government of Indonesia will strengthen the integrated approach for rights-based family planning (RFP) programming at the sub-national level. Indonesia has launched new initiative “Kampung KB” (Family Planning Village) that will help village communities improve their quality of life and welfare through family planning and family development programs. In addition, Indonesia is currently developing an integrated and Rights-Based Family Planning Strategy and its Costed Implementation Plan to be piloted in selected districts for further adoption and replication nation-wide.”*



## Youth



### Policy related to YFS developed

Currently developed under National Action Plan (RAN).



### National Action Plan for Youth

The Action Plan addressed eight (8) issues of school age and adolescent health including reproductive health. Currently, the Action Plan is in the drafting process to be updated for 2020-2024.



### BKKBN/MoH for Youth IEC

**BKKBN** developed PIK-R, a youth centre, with 12,137 PIK-R have been established in 6,982 sub-districts. **Ministry of Health** developed PKPR with coverage of 6,204 has been established nationally.



### Public-Private Partnership for YFS

Private sectors and non-governmental organizations are continuously supporting the Government of Indonesia in providing youth-friendly services (i.e. UNFPA, PKBI, Rutgers WPF, JHCCP)

## Right-based Family Planning (RFP)



### District CIPs developed

As one of the initiatives on CIP and RAD, Malang has developed a program namely “Contra War” (Contraceptive for Woman at Risk) – other districts are currently developing each own’s CIPs



### Integration of FP indicators in Local Government

Through advocacy process at the provincial and district level. To date, a total of 36 districts in 15 provinces had been successfully incorporated FP indicators to local govt’s plan. Supported by policy umbrella with Ministry of Home Affairs’s Decree No 82 year 2017.



### Piloting of RFP-MH strategy

Under the coordination of BAPPENAS, BKKBN, and MoH, with the support from UNFPA, developed the right-based family planning (RFP) strategy and its Costed Implementation Plan (CIP) for 2017-2019, integrated with maternal health piloted in 3 districts.



### National RFP Coordination Team

Led by the National Development Planning Agency (BAPPENAS), the team was established under the release of BAPPENAS’ deputy decree which members consist of partners from seven (7) ministries/governmental agencies

## Kampung KB Implementation



- Total Kampung KB: **14,939**
- Total Kampung KB with multi-sectoral collaboration: **5,396**



- a series of guidelines and modules have been developed to optimize the implementation of Kampung KB



- BKKBN has developed online monitoring and reporting system for Kampung KB (<https://kampungkb.bkkbn.go.id>)



- Per September 2019, the number of Kampung KB that submitted and updated data to the online system: **61%**.

**BKKBN**

BKKBN regularly conducts programs related to south-south exchange family planning. Within 2017 – 2019, a series of activities were carried out through 6 (six) programs, with the total of 92 beneficiaries



**MoH**

Under coordination of MoH, with support from Ministry of State Secretariat and JICA, the Government of Indonesia has conducted the TCTP (Third Country Training Programme) on the Maternal and Child Health Handbook within 2017-2019 with total of 15 country participants
