



PROGRESS ON FAMILY PLANNING 2020 (FP2020) COMMITMENTS IN

KENYA

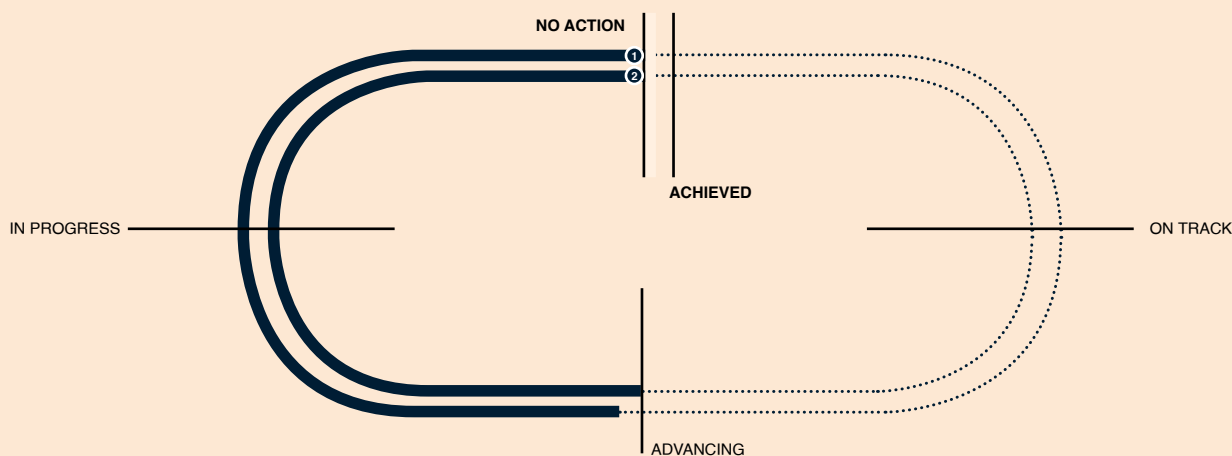
The government of Kenya commits to:

(1) increasing the national budget for family planning (FP) services, specifically through a budget line allocated to FP. By including contraceptives in the existing health insurance schemes, the government will bolster equitable access to FP for insured individuals. The government will also ensure postpartum FP services are covered in its Free Maternity policy, or *Linda Mama* program, which provides free care for delivery through an annual government investment of **3 billion Kenyan shillings**.

(2) strengthening private sector — including for-profit — partnerships through a total market approach (TMA) to optimize FP funding. Using the TMA, an all-sector strategy will differentiate groups according to their ability to pay and determine which market players can most effectively reach them. TMA cost-benefit analyses and scenario planning are also being carried out by Palladium and will be finalized before the end of 2017. This will provide information to support efforts of segmentation and improving efficiencies in FP service delivery. Most critically, the Palladium analyses will provide sufficient analysis and evidence on what is needed to move towards the implementation of a TMA for FP in Kenya.

IS KENYA ON TRACK TO ACHIEVE ITS FP2020 COMMITMENTS?

Since 2017, Kenya has made progress in improving access to FP services, including improvement of FP indicators. Currently, 23 out of 47 counties have developed a costed implementation plan (CIP) to ensure FP budget lines are reinforced. The Ministry of Health (MoH), with support from partners, has developed a TMA road map as a guiding principle to ensure implementation of FP services. MoH is deliberately working to expand access to adolescent and youth-friendly services in line with the National Adolescent Sexual and Reproductive Health Policy of 2015 by working with implementing partners.

Increase the national budget for FP services, specifically through a budget line allocated to FP



Total amount for procurement of FP commodities allocated annually in the national budget since fiscal year (FY) 2016-17

Kenya committed to increase budgetary support for the procurement of FP commodities. The government allocated \$7 million in FP 2016-17, and will double this amount to \$14 million in FY 2018-19 and FY 2019-20. Allocations totaled only \$4.2 million in FY 2016-17 and \$7.2 million in FY 2017-18, meaning the commitment was met in FY 2017-18.

In FY 2018-19, \$3 million was allocated, and in FY 2019-20, \$11.8 million was allocated to FP procurement. These figures indicate that this commitment hasn't been met for these years.

National budget line established for FP

Different FP partners have been advocating for the establishment of a national budget line for FP and submitted a memorandum to the Ministry of Finance for the increase of domestic financing for FP.

County budget lines created for FP

An FP budget line for Homabay county has been created as a result of combined efforts by different implementing partners.

FP fully included in existing National Health Insurance Fund (NHIF) and private insurance schemes

Ugunja Development Initiative (UDI) participated in community sensitization and awareness activities on the importance of the NHIF, which includes FP and thus covers NHIF recruitment. This was done in partnership with Amref Health Africa, NHIF Siaya and World Vision. Through integrated outreach, UDI also intensified mobilization and recruitment to the NHIF scheme in Siaya county.

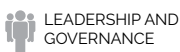

Private health workers' capacity to provide FP services assessed

A training needs assessment was conducted by different implementing partners who identified county health care providers sensitized on FP and recruited them as trainers of trainers.

Biannual field visits to private health facilities conducted

The biannual field visits to health facilities in 19 counties were conducted with support from partners such as Kisumu Medical and Education Trust (KMET), Matibabu Foundation and Omega Foundation. During such visits, challenges were identified and priorities to overcome them were put in place.

Health facilities supported to provide youth-friendly services

Omega Foundation has established and operated youth-friendly centers in health facilities (three in Homabay, two in Kisumu and one in Siaya), where it has trained health care providers on the provision of youth-friendly services. It has also provided continuous mentorship and engaged youth peer providers as agents for change and information sharing using youth-friendly information, education and communication materials. Other partners have conducted community outreach on referrals to youth-friendly centers, including rapid assessment on the impact of these centers. United Champions Advancing Humanitarian Actions Empowerment Center (UCAHAEC) and Marie Stopes Kenya trained health care workers on services.

The government of Kenya, together with development partners, convened the International Conference on Population and Development in Nairobi that brought member states from different countries. During the conference, the president of Kenya committed to ensuring zero unmet need for FP.

Parental and community support structures for pregnant adolescents established

Omega Foundation has been engaging youth peer providers who give health education at the community level and link clients to the facility for further management and support. It also supports community health volunteers (CHVs) who act as links between the community and facility in the Siaya and Homabay counties.

Effective referral systems for pregnant and lactating adolescents strengthened

CHVs and youth peer providers have been trained on how to refer clients, including lactating and pregnant adolescents, to health facilities to receive required health services. Youth peer providers work at the health facilities.

Annual quantification and forecasting of FP commodities for the public and private for-profit FP-CIP reported

The government organizes annual forecasting and quantification workshops for FP commodities. For FY 2019-20, partners supported different activities to ensure health care providers are able to participate in quantification and forecasting at their facilities.

County social and behavior change communication (SBCC) strategy developed for counties in the northern arid lands (NAL)

PSK, with other consortium members and through UK aid-funded Delivering Sustainable and Equitable Increases in Family Planning (DESIP) in Kenya project, developed a human-centered design FP SBCC strategy that is being implemented in different locations, including the NAL counties. The strategy is customized to each of the implementing counties: Baringo, Elgeyo Marakwet, Turkana and West Pokot.

The SBCC strategy has been developed at the county level and will be adapted to the national level. Partners are currently implementing activities on the SBCC that will later be evaluated.



FP champions trained and deployed in counties

PSK trained 1,197 community health workers and facilitated over 981 outreaches.
